

NON-SEXIST EDUCATIONAL MATERIALS

Dear People,

Hello from Men and Women Unlimited, a non-profit organization committed to the development of nonsexist educational materials.

We began in the spring of 1973, funded by "Opportunities for Youth" (O.F.Y.). Between May and August we developed a prototype kit containing booklets, audiovisual material, work sheets, educational games and suggestions for teaching in a non-sex-role-storeotyped manner.

During the summer of 1974, again funded by O.F.Y., we field-tested portions of the kit, continued development and research, and divided our prototype materials into individual packages pertaining to different subject areas and age levels.

This year it was our intention to have our packages printed and to establish a system for distribution. However, O.F.Y. turned down our application for funding. We were compelled, therefore, to re-evaluate our goals.

Fortunately, a recent small grant from the Department of the Secretary of State has given us the opportunity to organize and carry out an alternative to our original plans.

We have made arrangements to turn over our work and files to the Ontario Institute for Studies in Education (O.I.S.E.) in Toronto, who are developing and producing non-sexist educational kits themselves. During the next year they will be field-testing our material along with their own. They plan to then include some of our material within their educational packages.
