## BY-LAW' of TIE WLST KOOLENAY WOREN'S ASSOCLATLON

## Articlo 1 - Temme of admission of mombores thoix riante and oblications

a) Momborship in the Socioty shall be open to any woman upon payment of the requixed applicatian fee and annual duese.
b) Any porson who has rendered, ovor a reasonable period of time, meritorious servico to the society may be oleoted an honorary nember by sinple majority vote at any general meotinge
c) A 11 fo momber is an individuat who subecribes one hundred dollarg or mora.
d) The annual fea for memberehip shall be fifty cente or suoh other anmount as set by the directore from time to time.

- Any person in the employ of the society may be a member ofthe Society, but nos hore than one at a tiwe may be a director.

Articla II - Conditions under which memborahio coasos and rannat in which a member may be axpoliod
a) Membership in tho Soctety ahall terminate upon non-payment of annual foo.
b) Any Socioty momber may have her mombership torminated by an oxtraordinary resolution of the Sooiety passed by a two-thixds majority voto of the members present, providod that notice of such mecting spocifios that suoh a matter is to bo placed before the memborship.

Axticle III - Month fox holdine a Gononal Ho tine and modo ot. ©
notios required for calliner teneral and soceial moetinge
of the society, and number constituting a guorua at any auch weetingis and ristits of voting
a) The innual General Hetine of the socioty shall be held at a time and place designated by the Board of Directors during the month of Octobar.
b) A11 paid up mowbers ahall bo ontitiod to attend tho Annual Gonoral lueting and shall be notifiod thoreof. All paid up mombere shall be entitled to attend any regular or special meetinge and vote at such mectingse
c) Speoial meotings of the socioty may be called by tho President and/or tho Board, and a spocial woeting shall be oalled by the Board within 30 days on the Socretary's receipt of a writton request stating the business to be dealt with and signing by not lese than 10 mombers of the Society in rood standing.
d) The Lxecutive Committee may call a Board Meeting at any time, notice of which may be given in such manner as the fxecutive Comunittee may decide.
e) Ten percent shall constitute a quorum at Socioty meotinge. Three Dixectore shall conetitute a quorum of the Doard.
f) If a quorum ia not prosent, the meoting shall be adjourned and called again one weok hence at the same hour and ylace. and those present shail constitute a quorum.

Article IV - Apuointmont and removal of virectors and officore. and thoir dutios poworg and romunoration
a) The propexty and affairs of the society will be managed by a Boaxd of Directoxs which slual congist of five homber Direotors olected at the Socioty's annual mooting. All Directors shall be members in good tanding of the society. Directore ahail have full control of all revonue and expenditurea.
b) Tho togm of office of tho Hoard Chairyereon shall be two yeare with four Directore boing oleoted each membership year.
o) If a Directox ceasoz to sexve for any reason, the remidning Board at a reculax moeting shall appoint a mombor of the Sooiety to serve the unexpired term. All meabore of the Society shall be

b) The Society's seal shall not be fixed to any documents except by authority of the Board of Resolution and except in the presence of the President and/or Vice-President and two Dieectors
who shall each sign the sealed document.
Article VIII - Alteration of by-laws by extraordinary resolution,

These by-laws may be amended or re-enacted by an extraordinary
resolution passed by a twonthirds majority of votes cast by the
members present at any regular or special meeting of the Society,
notice of which shall state the intention to propose such resolution.
Article IX - Preparation and Custody of minutes of oroceedines of
medtincis of the society and of the Directors, and
other books and records
a) The Secretary shall keep the general Society records, including all minutes, lists and like reports. She will be responsible for a11 outeoing and incomeing correspondonce, ensuring that it is acted upon in accord with the Society Directors.
b) The Treasurer shall keep full and accurate accounts of all receipts and disburselients of the society in proper books of accounts and shall deposit all funds in the name and to the credit of the Society in such bank or banks as may be desienated.

## Article X -

Time and place at which books and records of the society shall be
available for inspection by members
The books and records of the Society may be inspected by any member of the Society at any time and in such place upon arrangement with the Secretary or Treasurer of the society.
