
She is just one example of a woman who falls in between the cracks in the systems. We do not feel this woman should be penalized for her inability to fit into a faulty system.


We urge you to address the issue of unjust taxation for those living on CPP disability benefits and await your reply.

As you are well aware, poverty among women is a huge concern in this country. I would like to draw to your attention the problems faced by women receiving CPP disability benefits.

A specific example is a woman aged 59 years old. Last year she received CPP disability benefits of \$583.00/month or \$6,996.00 per annum. Despite this outrageously low income this woman paid \$124.00 in income taxes.

Like others, this woman falls between the cracks.

- 1. She is not old enough to receive the benefits, subsidies and discounts enjoyed by those more senior, although many of them have a much larger income.
- 2. She does not have the advantage of medical coverage and access to additional benefits as do those in receipt of income assistance. People living on similar incomes from social services do not pay income tax.
- 3. Like a large portion of people to receive CPP disability pensions, this woman does not meet the criteria to be classified disabled or handicapped for the purposes of income tax. Therefore, she does not receive the benefit of income tax deductions.

Although we support the benefits received by these other groups, it is unfair that people so obviously disadvantaged must pay income taxes. This woman's \$7,000.00 annual income is <u>well</u> below the poverty line.

Please address this issue and re-assess the taxation paid on CPP disability benefits.




