I think this is what you want. In fact it's probably more than you need right away.

The final report includes the evaluation results. The evaluation documents are just the data gathering forms. The Loose Ends, Highlights, Update are three documents I produced at the end of the project that may or may not be of use. The Guidelines, Outreach Directory, Business Case, and the two research summaries are the closest I can get to the idea of a "package" of information produced by the project. I produced a lot of stuff on an as needed basis. There's also a paper trail of my assessment of the status of systemic equity in the construction sector (which I'll try to find and add to the end). The file WITT letter to CPC is the letter requesting the \$10,000. The LEIF Terms of Reference is something I produced last October to try to move the idea ahead at that time. Found the stuff on construction. The October chronicle is updated by the one in Jan. 2001. The submission to the CBT is significant.
