4.1 Community Coordination and Leadership

This category refers to linking with government and community services to facilitate an effective community response to women's needs and leading or participating in shared leadership on initiatives to improve services for women in the community.

- Attended 3 VAWIR committee meetings and 4 West Kootenay Women's Council meetings
- Partnered with the local health authority on a women's health project
- Participated in other community committees including the Nelson Food Coalition, the Transition House Community Advisory Committee (formerly Management Committee), the Gay, Lesbian, Bisexual, Transgendered Youth Group committee, Short-term Accommodation Committee
- Provided a feminist analysis of issues affecting women by providing feminist comment in the media, adding more feminist resources to our collection, providing a feminist perspective on committees

• Attended community development and public input meetings including meetings on women's safety issues, and a community committee to develop a proposal to increase collaboration within the community

 Communicated several times with Boundary Women's Centre, participated in the Provincial Reference Group and networked with Women's Centres throughout the province, joined the province-wide 52% coalition to raise awareness of women's issues in the provincial election

 Publicly commented on local issues of violence against women in the media (radio and newspaper), provided local and national commentary on politics, regularly shared information on events and issues electronically with contacts in the community and region

4.2 Information and Outreach Services

This category involves identifying and sharing information on services and resources for women (particularly those women who are victims of violence), promoting them locally, and operating additional information programs, as needed.

- The Centre was open for drop-in 16 hours per week, except between December 22 and January 2
- Monthly evening events were organized including an evening to meet women leaders in post-secondary education, a discussion on Internalized Oppression and Dominance, Micro Lending and Peer Lending Circles
- Three editions of the newsletter were published and distributed to members and in the community
- 923 women accessed services including computer and internet, resources and information, safer sex packages, free store and food supplies

4.3 Awareness and Prevention Programs

This category involves developing and implementing:

- strategies to raise the level of community commitment to eliminating violence against women.

- awareness/public education programs in other areas related to the social, economic and legal equity of women.
- Collaboratively organized an International Women's Day Celebration
- Submitted a brief on Custody and Access Issues to a consultant for the federal government
- Participated in Women Plan Nelson to promote women's safety issues in the public planning process
- Helped organize Prevention of Violence Against Women Week
- Participated in organizing a community meeting on food issues
- Met with researchers on issues such as Victim Empowerment, First Nations Health issues, and Sexual Assault response in hospitals

4.4 Organizational Support and Development

- Continued a Strategic Planning Process to develop a three year plan
- Researched and implemented increased security measures
